In 2015-2016: 3,772 students in need received support. Of those students, 436 participated in a weekend feeding program in partnership with the Food Bank, 225 benefited from direct purchases, and all 3,772 benefited from school supplies, clothing, grooming aids, and other in-kind donations we distributed. 560 students received case managed from our site coordinators. Seventy-three percent of the case managed students made academic improvement. Fifty-four students participated in service learning opportunities as peer tutors. 5,825 students at our 5 elementary and 4 middle school focus sites received**
