Communities in Schools helps students in need throughout Auburn and has more intensive support provided by our site coordinators at 4 elementary schools and all 4 middle schools. In 2016-2017:

3,664 students in need received support. Of those students, 438 participated in a weekend feeding program in partnership with the Food Bank, 247 benefited from direct purchases, and all 3,664 benefited from school supplies, clothing, grooming aids, and other in-kind donations we distributed. Five Hundred thirty one students received case managed from our site coordinators. Seventy-three percent of the case managed students made academic improvement. Sixty two students participated in service
